Important Information about the Law for the Control of Military Weapons (KrWaffKontrG)

The Law for the Control of Military Weapons (KrWaffKontrG) is an extremely complicated item of legislation, and, in connection with the ILA Berlin, the Federal Ministry for Economic Affairs and Climate Action has approved the use of a simplified procedure by Messe Berlin GmbH.

In accordance with this procedure exhibitors are required to adhere to the following regulations:

- 1. By registering online they are obligated to register any exhibits which are subject to the KrWaffKontrG using the form "Statement concerning Military Weapons".
- 2. Military weapons must be registered with Messe Berlin GmbH no later than four weeks prior to the start of the exhibition.
- 3. Upon termination of the event such items must be removed immediately from the exhibition site.
- 4. Domestic exhibitors/manufacturers must comply with the KrWaffKontrG (maintenance of diary etc.), in accordance with specifically defined, internal company arrangements.
- 5. Foreign exhibitors/manufacturers must submit a certificate issued by the government of their respective countries, or by an officially authorized government agency, listing the military weapons, and indicating that these are intended solely for exhibition at the ILA.

On entering and leaving the Federal Republic of Germany the required certificate must be presented to the customs offices at the border/airport/seaport, and, together with an exhibitor's pass, serves as a copy of the approval document as specified in Article 12, Para. 3 and 4 of the KrWaffKontrG.

At the termination of the exhibition the military weapons must be re-exported immediately from the Federal Republic of Germany.

For its part, Messe Berlin is required to notify the Federal Office of Economics and Export Control (BAFA) and the Federal Ministry for Economic Affairs and Climate Action of the category, type and quantity of the military weapons that have been registered for the exhibition.

Please note that failure to strictly observe the regulations of the KrWaffKontrG is a punishable offence under German law.

I. Missiles

- 7. Guided missiles
- 8. Unguided missiles (rockets)
- 9. Other missiles
- 10. Firing installations (launch apparatus and equipment) for weapons in categories 7 and 9, including portable firing installations for anti-tank and anti-aircraft guided missiles
- 11. Firing installations for weapons in category 8, including portable firing installations and rocket launchers
- 12. Engines for weapons in categories 7 and 9

II. Combat aircraft and helicopters

- 13. Combat aircraft provided with at least one of the following features:
 - integrated weapons system, equipped in particular with targeting, fire control and corresponding avionics interfaces
 - integrated electronic weapons
 - integrated electronic weapons delivery system
- 14. Combat helicopters provided with at least one of the following features:
 - integrated weapons system, equipped in particular with targeting, fire control and corresponding avionics interfaces
